RESOLUTION DESIGNATING SNOWMOBILE ROUTES AND TRAILS

WHEREAS, the snowmobile clubs in Waunakee have requested certain streets and alleys be designated as snowmobile routes to allow them to travel to and from the trails located outside of the Village limits; and,

NOW, THEREFORE, BE IT HEREBY RESOLVED, by the Village Board of the Village of Waunakee, County of Dane, State of Wisconsin, that the following streets and alleys be designated as snowmobile routes:

- Rupert Road from Raymond Road to, and including, Lot 130 of the Third Addition to Dormal Heights;
- Raymond Road from Rupert Road to Agnes Avenue;
- Agnes Avenue south of Raymond Road to Parkside Drive;
- Parkside Drive from Pasadena Parkway to Ganser Drive;
- Ganser Drive from Parkside Drive to Woodland Drive;
- Capitol View Court to Ganser Drive;
- Spahn Drive west of Ganser Drive;
- Centennial Parkway from Monterey Lane to Stanford Drive
- Stanford Drive from Centennial Parkway to, and including, Lot 10 of Centennial Heights;
- Holiday Drive from Woodland Drive to Sunset Lane;
- Sunset Lane from Holiday Drive to State Highway 113;
- O'Malley Street from Eighth Street to State Highways 113 & 19;
- State Highways 113 & 19 from O'Malley Street continuing north on State Highway 113;
- ~~Madison Street from Main Street north to Lexington Drive, including Lot 69 of Capitol Estates; Easy Street.~~
- Kingston Way from Wexford Drive to South Street;
- South Street from Kingston Way to, and including, Lot 1, Block 5 of Castle Crest;
- Simon Crestway from Wexford Drive south to Woodland Drive;
- Winston Way from Bristol Drive to, and including, Lot 5, Block 12 of the Third Addition to Castle Crest;
- Bristol Drive from Winston Way to Knightsbridge Road;
- Winston Way from Wexford Drive to, and including, Lot 12, Block 1 I of the Fifth Addition to Castle Crest;
- Wexford Drive from Kingston Way to Cambridge Court;
- North Cambridge Court;
- Division Street from Verleen Avenue south beyond Woodland Drive to, and including, Lot 176, Fourth Addition to Castle Creek;

- Dover Drive from Division Street to Woodland Drive;
- Cardigan Bay;
- Woodland Drive from Dover Drive to Tierney Drive;
- Wimbleton Way from Dover Drive south to Woodland Drive;
- Wodland Drive from Holiday drive to Aldora Lane;
- Dorn Drive from State Highway 113 to Raymond Road;
- Fifth Street from Dorn Drive into Ripp Park;
- Knightsbridge Road from South Street to Division Street;
- Elizabeth Street from Raymond Road to Dorn Drive;
- John Street from Raymond Road to Dorn Drive;
- Century Avenue/Highway Q from Centennial Parkway to Woodland Drive;
- Cheyenne Pass to Lexington Drive;
- Lexington Way to Lexington Drive;
- Lexington Drive
- Hartford Cove;
- Verleen Avenue from Madison Street to State Highway 113;
- Muirfield Court;
- Alley between Topeka Trail and Verleen Avenue from Madison and including, Lot 98 of the Sixth Addition to Pleasant View Heights
- Alley between Verleen Avenue and Patrick Avenue from Madison Street to Division Street;
- Alley between Patrick Avenue and Prospect Road from Madison Street to Division Street;
- Alley between Main Street and Cross Street from Baker Street to Madison Street;
- Alley between Main Street and Fairview Court from, and including, Lot 3, Block 1 of O'Malley Addition to, and including, Lot I of Fairview w Addition;
- Alley between Second Street and Third Street from O'Malley Street to Short Street;
- Alley between Third Street and Fourth Street from O'Malley Street to South Street;
- Alley between Fourth Street and Fifth Street from Holiday Drive to South Street;
- Alley between Fifth Street and Sixth Street from Holiday Drive to South Street;
- Alley between Sixth Street and Seventh Street from Holiday Drive to Century Avenue/Highway Q;
- Greenway drainage way existing between Division Street and M shall Drive;
- Marshall Drive from Greenway/drainage way to State Highways -113 &19;
- Turnberry Drive across North Fairbrook Drive through Six Mile Creek Bridge and follow Six Mile Creek easement to Village limits;
- Private properties bordering Prairie Park to a trail along the west and north

boundaries of the park to Madison Street.

- Augusta Drive from Augusta Court to N. Fairbrook and N. Fairbrook to Turnberry Drive.
- Kopp Road from State Highway I 13 west to the Village limits;
- Northwest along the railroad tracks from Kopp Road to the Village limits.

BE IT FURTHER RESOLVED, that only citizens of Waunakee may use the trails as access to and from trails located outside the Village limits.

BE IT FURTHER RESOLVED, that the maximum speed allowed on snowmobile trails within the Village is 15 m. p. h.

BE IT FURTHER RESOLVED, that all snowmobile routes must be marked with signs and the cost of the signs shall be borne by the local snowmobile clubs.

BE IT FURTHER RESOLVED, that the trails will be open for use during the times that the Dane County public trails are open.
